

**RELEASE AND INDEMNIFICATION AGREEMENT
In Your Dreams Farm / RIFNA**

To induce In Your Dreams Farm, Inc. Anita Ryan, Keely Ryan, and their agents, barn workers, trainers, servants or employees, and all owners of horses boarded used or not used in riding and lessons programs including intercollegiate or interscholastic associations at farm (hereinafter "the Farm"), to allow the use of the facilities of the Farm, and in consideration of the use of the same, we the undersigned, by executing this writings, agree to hold harmless, discharge, release, and indemnify the Farm with respect to any claims, causes of action, injuries, damages, cost or expenses, or loss of myself, my family, my children, my friends, guests, spectators accompanying any of the above persons to the Farm and others arising out of or in anyway connected with the use of the facilities of the Farm by such persons, to include damage, loss or injury of any kind to any horse or other property or person, and whether on, or off the facilities of the Farm, and whether any such liability, damage, cost or loss be due to acts or omissions of myself, my family, my children, my friends, guest spectators accompanying any of the above persons to the Farm or others or by act or omission of the Farm, and for all risks of using the facilities of the Farm, of riding horses on or off the facilities of the Farm and of boarding horses with the Farm On behalf of myself, my heirs and assigns, executors and administrators, I/We hereby **waive and release forever any and all liability and all claims for damages against Riders Interscholastic Federation of North America, Inc. (RIFNA), its Board of Directors, Instructors, Administrators, Volunteers, Sponsors, Educational Institution members or volunteers, riding facility members, and/or Employees** for any and all injuries and/or losses I/my son/my daughter/my ward may sustain associated with my child's voluntary participation in RIFNA activities. Similarly, the undersigned **AGREES NOT TO SUE** In Your Dreams Farm, Inc. Anita Ryan, Keely Ryan, their agents, barn workers, trainers, servants, employees, and all owners of horses used or not used in riding and lesson programs including intercollegiate or interscholastic associations at the farm with respect to any claims, causes of action, injuries, damages, cost or expenses, or loss to myself, my family, my children, my friends, guest, spectators accompanying any of the above persons to the Farm and others arising out of or in any way connected with the use of the facilities of the Farm by such persons, to includes damage, loss, or injury of any kind to my horse or other property or persons, and whether on, or off the facilities of the Farm, and whether any such liabilities, damage, cost or loss shall be due to acts or omissions of myself, my family, my children, my friends, guest, spectators accompanying any of the above persons to the Farm, or others or by act or omission of the Farm, and for all risks of using the facilities of the Farm, of riding horses on or off the facilities of the Farm and of boarding horses with the Farm. In addition, the Farm shall not be liable for any loss due to accident, illness, fire, or theft. It is the responsibility of the Rider to carry full and complete insurance on his horse, personal property and himself.

Amendment to this release indemnification to include traveling to and from all horse shows, tack stores, all horse intercollegiate or interscholastic events by all forms of travel (planes, cars, buses, boats, etc.), taking members to the store to buy lunch or participation in unmounted events such as clinics, lectures, games, fundraisers, etc.
